These positions provided me with insight and information on the workings of GFF. My administration began with newly Board elected officers and five new Board of Directors. The officers forming my administrative team include newly elected Vice President, GF Roslyn Thibodeaux Goodall; Secretary, Emily Monago; Assistant Secretary, Jaqueline Randolph; and returning Financial Secretary Tamara Turnley Robinson and Treasurer Lori Parker. The five new Board of Directors serving three year terms are Lynnette Crenshaw (Cleveland), Faith Hairston (Toledo), Emily Monago (Toledo, member-at-large), Sheryl Smith (Orlando), and Lashell Vaughn (Memphis). My role is to provide leadership, bring this group of volunteers together and form a cohesive team to accomplish the goal of the Girl Friends Fund.

Unfortunately this program year, we lost two icons of the Fund. GF Mirian C. Shropshire (Atlanta) was the fourth President of the Girl Friends Fund from 1995 – 2000 and passed in October of 2021. GF Kathlynne Duffy Espy (Columbus) served as a Director from 2019 – 2021 and passed this year. This first year of my administration "Girl Friends Fueling the Future" was a continuation of striving to make GFF as effective and efficient as possible.

"Bringing Dreams to Life One Scholarship at a Time"

The Girl Friends Fund, Inc (GFF, Inc.) was incorporated in Texas on February 22, 1988 and was recognized as a non-profit charitable organization by a five-year advance ruling from the Internal Revenue Service (IRS) on June 30, 1989. The Final Ruling of the IRS that the GFF, Inc. continue operation as a non-profit charitable organization was received from the IRS on December 1, 2008.

The GFF, Inc. was the brainchild of Girl Friends Ersa Posten and Helen Wright, past national presidents of the Girl Friends, Inc. (GF, Inc.). Prior to the 1987 Girl Friends Conclave, GF, Inc. then national president GF Carolyn Wells appointed a three-member committee to explore the feasibility of securing a 501C-3 public charity tax exemption from the IRS for the GF, Inc. Members of the committee were GFs Joan Sessoms Ford (Chairperson), Helen Wright (GF Advisory Board Chairperson) and Yvonne Gandy. The committee's recommendation to the delegates to the 1987 Girl Friends Conclave approved the establishment of a separate charitable corporation. Tax-deductible contributions could be made to this fund. The mission of this corporation was to provide financial assistance for college bound students who demonstrated financial need and distribution of proceeds from fundraising for other charitable purposes. This separate fund was named "The Girl Friends Fund" (GFF) by vote of the Conclave delegates.

As required for incorporation in Texas, initial Board members elected were Girl Friends Rebecca Kingslow as Chairperson, Lucille Blondin and Joan Sessoms Ford as Directors. They in turn elected interim officers GFs Konnetta P. Sparks, President; and Yvonne Gandy, Secretary-Treasurer to serve until the first GFF, Inc. Board of Directors meeting. As Legal Counsel, Joan Sessoms Ford was charged with preparation of all documents necessary for incorporation and filing with the IRS for tax exempt charitable status. Five members of the Dallas Chapter served as incorporators and signed the document for filing for incorporation on December 22, 1989.

The first meeting of the Girl Friends Fund, Inc. Board of Directors was held at the Peabody Hotel in Memphis, Texas on May 27, 1989, and was convened by Interim President, Konnetta Sparks. Upon her election as the first president of the GFF, Inc., Chrystine Shack assumed the presidential role and proceeded with the meeting. Other initial officers were GFs Margaret Bush Wilson (Vice President), Cecile Springer (Secretary) and Lucille Blondin (Treasurer.) The first Directors were GFs Paquita Attaway, Lucille Blondin, Joan Sessoms Ford, Mae Johnson, Rebecca Kingslow, Irma Roy, Margaret Rucker, Chrystine Shack, Cecile Springer, Margaret Bush Wilson, and Konnetta P. Sparks (ex-officio). A projected three-year budget needed for filing with the IRS was developed by Yvonne Gandy, Konnetta Sparks, Cecile Springer and Helen Wright, dated May 27, 1989. Revised by-laws developed by Joan Sessoms Ford were reviewed and commented upon by the GFF, Inc. Board and the GF, Inc. membership and were approved on May 24, 1990 at the GFF, Inc. first annual meeting in Orlando, Florida and signed by Chrystine Shack (President), Joan Sessoms Ford (Legal Counsel), Cecile Springer (Secretary) and Margaret Bush Wilson (Vice President).

The first fundraiser of the GFF, Inc. was a Girl Friends Fund Wheel. This was a raffle spearheaded by GF Paquita Attaway on May 27, 1992 at the GFF, Inc. Annual Meeting in Pittsburgh, PA. GFs Rebecca Kingslow and Lucille Blondin presented the framework of the GFF, Inc. scholarship program to the Board, and the first scholarship was awarded in 1995 under the guidance of GF Florence Sharpless as Scholarship Chairperson.

The Girl Friends Fund, Incorporated Endowment Fund was established in 2002 during the administration of GF Esther C. Marioneaux for whom the Endowment Fund was later named during the presidency of GF Lynda Carroll. GF Lynda awarded the first Esther C. Marioneaux Endowment Fund medallions to each Girl Friend who made a one-time \$250 donation to the Endowment Fund. This practice has been continued by each subsequent president. In addition to the General Scholarship Fund, through the beneficence of Girl Friends and/or their families, the GFF, Inc. has created five additional "named scholarships," called "Scholarships of Distinction": the GF Carolyn M. Carter Memorial Scholarship, the Anita Peek Gilger, MD Trust; the GF Juanita P. Humphrey Scholarship; the GF Gwendolyn G. Johnson Scholarship; and the GF Carole Temple Phillips Scholarship.

The presidents of the GFF, Inc. have all spearheaded outstanding activities.

GF Konnetta P. Sparks (1989), Girl Friends, Inc. President in 1989, and interim GFF, Inc. President in 1989, led the establishment of the GFF, Inc. through every stage of its creation. She is considered the "Mother of the Girl Friends Fund, Inc.", and evidences the close bond between the GF, Inc. and the GFF, Inc.

GF Chrystine Shack (1989 – 1992) oversaw the approval of the Revised Bylaws, the approval of the first GFF, Inc. fundraiser and development and advancing of the framework for the Scholarship Program during her tenure.

GF Helen K.Wright (1992 – 1995) initiated a significant fundraiser of printing the GFF, Inc. bylaws in booklet form and sold to Girl Friends for \$10 each booklet and assured the purchase of the first Certificates of Deposit by the GFF, Inc.

GF Miriam Shropshire (1995 – 2000) worked tirelessly to raise money for GFF, Inc. scholarships.

GF Esther C. Marioneaux (2000 – 2002), in addition to starting the GFF, Inc. Endowment Fund, changed the composition of the Board to create transition terms to ensure that experienced Directors always remained a part of the Board.

GF Lynda P. Carroll (2002 – 2005) initiated the giving of medallions for contributions of \$250 to the Endowment Fund. She oversaw the renaming of the Endowment Fund in honor of GF Esther C. Marioneaux, and initiated perpetual plaques inscribed with the names of Girl Friends giving \$250 or more. GF Linda also prepared the first Annual Report.

GF Phoebe A. Haddon (2005 – 2007) consulted with a Certified Public Accountant (CPA) to identify GFF, Inc. financial data inadequacies and proposed a contract with that same CPA to correct those inadequacies and preserve the GFF, Inc.'s tax exempt status.

GF Carole T. Phillips (2007 – 2010) worked with the GFF, Inc.'s CPA in retrieving needed financial data for filing with the IRS. She secured the IRS Final Determination letter of tax exemption as a public charity for the GFF, Inc. required after the five-year advance ruling period. She created the Endowment Fund Certificates to honor donations beyond the initial \$250 donation. The Carole Temple Phillips named scholarship was created in 2010 by the then Board of Directors and made a recurring scholarship by GF Carole in 2014.

GF Elaine Effort (2010 – 2012) launched the Girl Friends Fund, Inc. website, with a generous donation from the family of Cleveland GF Lillian H. Gregory, with legacy Girl Friends in the Cleveland, Potomac and California chapters. The GF Fund's interactive website allows scholars to apply online, encourages chapters to share special events and updates, and makes it easy and safe for GF members, family members, friends and other community and business resources to support the Fund through online donations.

GF Andrea L. Johnson (2012 – 2013) completed a comprehensive revision of the GFF, Inc. bylaws. She contracted for, and finalized, a complete GFF audit by a CPA established a Conflict-of-Interest Policy for the Board and established the GF Gwendolyn G. Johnson Scholarship in honor of her mother.

GF Cynthia Carter Cole (2013 – 2015) oversaw the GFF, Inc.'s most successful Silent Auction, partnering with St. Johns Knits to develop "GFF Shopping Days" that provided members a discount and allowed GFF, Inc. profit sharing. She also secured underwriting of a portion of the GFF, Inc. Luncheon by St. Johns Knits. GF Cindy partnered with the David Yurman Outlet in Las Vegas, which provided members discount shopping. She established the GF Carolyn M. Carter Scholarship in her mother's honor. GF Cecelia B. Henderson (2015 – 2017) commissioned a limited-edition bracelet engraved with the GFF, Inc. logo on one side and 'Bringing Dreams to Life'' on the other side. Bracelets were marketed to Girl Friends as a fundraiser. She also started the GFF, Inc. Book Fair in 2017 through partnership with Barnes and Noble. She initiated personalizing the Esther Marioneaux Endowment Fund Medallions with the name and Conclave date of the donors.

GF LaVerne N. Boyd (2017 – 2019) successfully secured the trademarking of the GFF logo and the motto "Bringing Dreams to life" and initiated the implementation of a QuickBooks Financial Program for the membership of the GF, Inc. GF LaVerne commissioned a commemorative sterling silver bracelet, to memorialize the 2019 New York and future Conclaves. A Pioneer Campaign was also originated under her administration which, concurrently with the 30th Anniversary of the Fund, celebrated 48 Pioneer Girl Friends who initiated and formed the foundation for the Fund in a historically successful campaign at the 2019 Eunice Shreeves Luncheon.

GF Ann E. Walters-Pope (2019 - 2021) advanced technical tools to facilitate communication with members and launched an individual member email communication system to reach the Fund's over 1700+ members.

The amendment to the Bylaws of The Girl Friends[®], Inc., including the provision that the funding from the National Project will now be awarded to The Fund on even years passed successfully. GF Ann implemented an online donation platform, Give Lively, that tracks donations and immediately sends Thank You responses. During this unprecedented pandemic, GF Ann designed and implemented the first ever Giving Tuesday Campaign that raised over \$16,000. Additionally, under her administration a first-time partnership with the Alzheimer's Association was established resulting in the funding of a named scholarship and the Fund's participation in their R25 grant that ensures a recipient will be a GFF Scholar. She designed the artwork for the ScholarSip campaign mug which collaboratively realized revenues of more than \$10,000, selling nearly 550 mugs. The GFF Bylaws were reviewed thoroughly, and proposed amendments sent to the members for review and approval. GF Ann created the 2021 Eunice Shreeves Scholarship luncheon format and theme, Pairings with a Purpose, which for the first time sold an unprecedented 280 tickets with income in excess of \$40,000.

All members of The Girl Friends, Inc. are members of The Girl Friends Fund, Inc. We are one team with one mission. In recognition of the special importance of access to higher education for all and despite widespread economic instability and rising tuition costs we remain committed to eradicating the inequalities in educational opportunities in particular for African American young women and men that are low income and under-represented in universities

and colleges across America. We have strength in numbers! We are a lifeline to our aspiring scholars and will remain so!

We gratefully acknowledge the historical work of the 2015 – 2017 History Committee: Co-Chairs GF Nina Jennings and GF Sheila J. Williams, the 2001 History of GF Cecile Springer, and the efforts of G.F. Lynne Bannister.

We also acknowledge GF Joan Sessoms Ford, Esq. for providing this history write-up and also note that additional updates were added in May 2021.

The goal of The Fund is to raise money to support college

scholarships for high achieving, African American scholars, who otherwise might struggle with financing their education. In my role as Vice President, I endeavored to remain knowledgeable of all functions of the board, especially as this position would be expected to function in the absence of the President and, in the event she is unable to fulfill her tenure.

The President of The Fund and I held routine conversations, to discuss board activities. In addition to supporting the President, other officers and committee Chairs, I was tasked with Chairing the Corporate Development Committee. Many corporations offer to match donations to non-profit organizations. I worked with the Jewelry Special Events co-chairs to finalize work on the Cancun Charm.

I attended regular meetings of the Planning Committee for the Eunice Shreeves virtual celebration and reached out to several organizations to identify one that could provide a video for the event. I then worked with the selected vendor to effect the agreement for the virtual event.



Girl Friends Fund Scholarship Committee was pleased to provide opportunities for Girlfriends across the country to support student success through the Girl Friend Fund, Inc. The Scholarship Committee was tasked to organize and execute the 2021 – 2022 Scholarship Cycle and Scholars Renewal Process.

The Scholarship Committee Members are: GF Sonya Goldsboro (Las Vegas), GF Faith Hairston (Toledo), GF Annette Johnson


(Albany), GF Jacqueline Randolph (New Haven), GF Cheryl Smith (Orlando), GF Nedra Starling (Cleveland), and GF Tamara Turnley-Robinson (Atlanta).

2021 Scholars Renewal Process

Each year, the Scholarship Committee reaches out to our scholars during the months of May – August 2021 to encourage the scholars to renew their scholarships. The scholars are eligible to renew the scholarship annually (up to four (4) years consecutively). The scholars must meet the renewal process criteria: (a) a minimum cumulative 3.0 GPA at the end of each academic year; (b) enrolled full-time in an accredited four-year undergraduate institution; (c) completion the Returning Scholars Renewal Form; (d) official transcript; and (e) enrollment verification.

- 47 Past scholars were eligible to reapply for the scholarship with 41 scholars reapplied for the scholarship
- 40 scholars met the renewal requirements and received the annual scholarship which included nine (9) \$1,000 scholarships and one (1) scholars who received the GF Carolyn M. Carter Scholarship of \$3,000 to assist with cost of medical school applications.
- The scholarship checks were distributed in September 2021 along with the 16 new 2021 Scholarships.



For the 2022 – 2023 renewal scholarship cycle, the Scholars will be emailed in May 2022 with instructions regarding the online renewal form and submission of an official transcript and enrollment verification by July 31st. The online renewal form will be available on the Girl Friends Fund website June 1st – 31 st. Scholarship checks will be distributed in September 2022.

2022 New Scholars Cycle

For the 2022 Scholarship Cycle, Chapter Presidents and Chapter Liaisons received the Scholarship Application through email in November 2021. The committee conducted a training session on January 30, 2022 with 10 Girlfriends attending the session. With the March 1st deadline, the Scholarship Committee received 21 applications which was a decrease of 10 applications from last year.

INVESTMENT REPORT



The Girl Friends Fund (GFF)'s investments are managed by Ameriprise Financial Services Incorporated (AFSI) under the direction of William Babgy, the account manager since it was established in 2014. As voted upon in 2020, all scholarship funds contributed to the GFF would be held in this endowment account and will be called the Esther Marioneaux Endowment Fund. This account now affords the GFF the opportunity to fulfill its mission

of providing college scholarships to deserving youth.

In 2021, the Investment Committee recommended and the board approved that two full scholarships of \$6,000 each be awarded from this Ameriprise account. The Investment Committee will continue to monitor the performance of this account and determine annually the funds that will be applied to reoccurring scholarships.

During the past year, in collaboration with the Finance Committee, all banking and investment accounts were reviewed for their objectives and for their operational functions and management. It was recommended by the Treasurer and approved by the GFF Board of Directors that several operational accounts holding scholarship funds be combined. It was also approved by the GFF Board that short term investment options be researched and considered for the non-interest-bearing operational account holding restricted scholarship funds designated for recipients who have been granted full four-year scholarships of \$6,000 each. Based upon our goal of preserving the capital to be made available as needed during a four-year period, the Investment Committee met with Ameriprise to consider investment options. It was advised that we establish a separate managed account having a moderately conservative portfolio allocation.

This account, referred to as the GFF Restricted Scholarship Endowment Account, was established at year-end 2021 with a transfer from the operational account of \$140,000. Funds with be withdrawn annually to fulfill our commitment to current scholarship recipients.

INVESTMENT REPORT

Given the volatility of the markets in 2022, regrettably, the two GFF Ameriprise accounts decreased in value as reported by our account representative, William Bagby. The Investment Committee will continue to be vigilant in monitoring the performance in light of current conditions and make adjustments as needed. Respectfully Submitted,

Members of The Girl Friends Fund, Incorporated,

As the Financial Advisor to The Girl Friends Fund, Incorporated investment accounts managed by Ameriprise, I am pleased to provide an update on your account.

The Girl Friends Fund (GFF)'s Investments are professionally managed by Ameriprise Financial Services Incorporated (AFSI) historically in an Actively Diversified (AD) fund for Moderately Aggressive investors. The investment objective is to deliver risk-adjusted growth of capital to moderate aggressive investors. For the calendar year 2021, this Fund enjoyed a modest return of 6%. In mid-December of 2021, the GFF established another managed account called the GFF Restricted Scholarship Funds in the amount of \$140,000 with a conservative investment asset allocation.

Challenged by the continuation of Covid concerns, inflations issues, Federal Reserve policy changes, and the Russian conflict, the June 30, 2022 performance returns were negative in both accounts. The GFF, Inc. account was down 18% and the GFF Restricted Scholarship Fund account reported a 9% decline. Combined balances ended the year at \$511,481.

MEMBERSHIP MEETING MINUTES

Annual Meeting of the Membership Minutes June 14, 2022 8:30pm - 10:00pm EST via Zoom

The meeting was called to order at 8:40pm by Board President GF Marie Latham Bush. Board Secretary GF Emily Monago was asked to call the roll.

Officers Present: GF Marie Latham Bush (President), GF Roslyn Thibodeaux Goodall (Vice President), GF Emily Monago (Secretary), GF Jacqueline Randolph (Assistant Secretary), GF Tamara Turnley-Robinson (Financial Secretary), GF Lori Parker (Treasurer), and GF Tracey Allison (Parliamentarian)

Board Members Present: GF Lynnette Crenshaw, GF Margaret Gaines Clark (by means of office), GF Cecilia Henderson, GF Jacqueline Hrabrowski, GF Annette Johnson, GF Fawn Robinson, BF Frank Sims, GF Lashell Vaughn

Directors Absent: GF Jacqueline Bontemps, GF Faith Hairston, and GF Cheryl Smith

Chapters Represented: Albany, Atlanta, Baltimore, Buffalo, Charlotte, Cleveland, Columbus, Dallas, Las Vegas, Louisville, Memphis, Miami, New Haven, Orlando, Pittsburgh, and Toledo

The minutes were read from 2021 GFF Annual Meeting of the Membership. BF Frank Sims (Board Member) moved that the minutes be accepted as read with the necessary corrections. GF Jacqueline Randolph (Assistant Secretary) seconded.

Board President, GF Marie Latham Bush greeted the attendees and congratulated and welcomed our newly elected GF President GF Courtney Moore from the California Chapter. She thanked all the GFF Board Members, Committee Chairs, and GFs for their support and work during the first year of her presidency of the GFF Board. At the May 12 – 15, 2022

Conclave in Cancun, President GF Latham Bush gave a report to the delegates, executive officers, and members at the first plenary. The report she gave emphasized that all Girl Friends are members of GFF and made a call for their expertise in fundraising and highlighted that the more money raised the more scholarships we can give to support students' education. GF Danielle Brown, co-chairman of the Conclave reached out to offer her expertise in helping GFF raise corporate funds for scholarships. GF Brown has an excellent track record raising corporate funds for Jack and Jill of America, Inc. and Links, Inc. Several other GFs also offered to help raise funds for GFF. The GFF will receive money for the national project in 2024. In summary President GF Latham Bush stated that the **Goals for GFF in 2022-2023 are to:**

- 1. Raise awareness of GFF with emphasis on all GFs become involve in some capacity to support GFF;
- 2. Increase corporate funding support;
- 3. Improve finances by working closely with a financial advisor;
- 4. increase 80% renewal rate for scholars and providing new guidelines to support renewal;
- 5. Increase awareness and giving of matching funds for scholarships;
- 6. Add 15 new scholars or more valued at minimum \$90K in awards;
- 7. Continue updates to the GFF website to increase traffic for the GFF store and other GFF information; and
- 8. Continue to make the GFF better.

In conclusion, President Latham Bush extended her gratitude to all.

Treasurer's and Financial Secretary Updates: GF Lori Parker (Treasurer) noted that her responsibility included keeping meticulous records for GFF. As part of this she had a significant role to play in facilitating the consolidation of GFF accounts from five to three accounts and opening a new Ameriprise Financial Services, Inc. account. GF Tamara Turnley Robinson (Financial Secretary) reported that through meticulous record keeping of GFF financial transactions, all scholarship balances were reviewed in the amount of \$121,069.85 with an ending Restricted Scholarship Fund balance of \$493.23. The ending balance in the GFF Operating Account is \$158,769.67. Reports will be filed for audit.

As recommended by GFF President GF Marie Latham Bush, please review reports of the Officers and Committee Chairs in the 2022 Annual Report.

Board of Director Elections There were no Officers or Directors elected or re-elected. Per the bylaws

GF Marie Latham Bush whose term is completed June 30, 2022 is allowed an additional year to complete her term of office. "Directors who are elected to an Office of the Corporation with a minimum of one (1) year remaining on their respective Board terms shall be allowed to extend such terms with the Corporation to complete the term of office to which they were elected. (Article IV. Board of Directors, Section 2. Number and Tenure a). Jackie Hrabowski who is eligible for re-election for second term "will be automatically eligible for re-election to a three-year term" if she choses. (Section 2-Number and Tenure b)

Committee Reports (Please review the reports in the 2022 Annual Report):

Eunice Shreeves Scholarship Fundraiser: GF Katrina Barry (Chair) thanked her Co-chair GF Alicia Gant and all committee members. GF Barry reported that the virtual event took place May 5, 2022 6 – 7:30Ppm EST. The theme was, "Sundresses, Sunsets, and Scholarships: Party with a Purpose!!"There were 140 tickets sold, 38 GF Chapters participated in the chapter president and liaison slideshow. There was a beautiful tribute to the late GFs Kathy Espy and Mirian Shropshire. Two scholarship recipients gave testimonials on how beneficial the scholarships are to them. The 2022 class of Scholars were announced. The event ended with a mixologist and signature cocktail and dancing to a music from a DJ.

Corporate Development: GF Roslyn Thibodeaux Goodall (Chair) recognized GF Ann Waters Pope and all on this committee and extended her gratitude. A mission success was the scholarship brochure and the solicitation letter. The solicitation letter highlights that more than 800 scholarships valued at more than \$1 million has been awarded. Plans are in the works to engage corporate donors with making donations before they finalize their budgets with this in mind, 100 solicitation letters will be mailed to potential new and current corporate donors. Matching corporate gifts is being developed on the GFF website. AmazonSmile is a way to donate to GFF and all GFs are encouraged to make a donation through this opportunity.

Investments Committee: GF Jacqueline Hrabrowski, (Chair) expressed her gratitude to all committee members. They established a spending policy for the Esther Marioneaux Fund. The investment committee had recommended a consolidation of GFF accounts. The accounts were consolidated into two Ameriprise Financial Services, Incorporated under the guidance of a financial manager who has worked with the account since 2014. The accounts are the Esther Marioneaux Endowment Fund (conservative investments) and GFF Restricted Scholarship Account (moderate investments) with the latter established with a transfer from the GFF operating account for \$140,000. These were established at year-end 202. Combined balances for the two accounts at the end of year was \$511,481. Major donors: GF Eva Martine and GF Jacqueline Bontemps in addition to other GFs who made large donations were recognized.

Scholarships: GF Fawn Robinson (Chair) provided snapshot of the annual report by highlighting scholarships that were awarded in May with recipients receiving their checks in September. Forty-seven scholarships were renewed. Fifteen new scholarships were awarded. There will be an estimated \$94,000.00 in checks going out in 2022. There were 21 applications received and 16 reviewers. GF Robinson thanked all seven committee members and all 16 application reviewers.

Silent Auction: GF Sonya Goldsboro (Chair) recognized the committee members and thanked them. Appreciations and gratitude extended to all the GF, Inc. chapters and individuation GFs who supported their efforts, including individual and Chapter e-cards were sent to everyone who made a donation as of May 17, 2022. Due to the COVID-19 Pandemic Girl Friends were asked to make monetary donations as a chapter and/or as individual GFs. Confirmed by the GFF Financial Secretary \$4,425.48 was raised.

Fundraising Special Projects: GF Joyce Ford Quick (Chair) thanked her Co-chair GF Cecilia Henderson. GF Ford Quick reported that 61 Palm Charms, 8 Bracelets, 3 GF Pendants, and 12 Liberty Bells were sold. There are 10 GF Margarita Glasses remaining that are for sale. Work will be conducted during the summer to sell the remaining items remaining in inventory.
