Our Corporate Development committee and individuals worked hard to reach our financial goal of raising \$150,000 for the 2023 program year. We not only reached but exceeded our goal.

Promedica Healthcare System continued our partnership this year that was cultivated last year. A summer internship program for college sophomores, juniors, and first semester seniors interested in Healthcare was developed and implemented this summer. Five positions were available and Girl Friends Fund was guaranteed one of the positions.

Our major fundraiser for the program year is the Eunice Shreeves Scholarship Luncheon. Great detail and much work is required to make this event a success. This was the first in person luncheon since 2019. GFF President and Eunice Shreeves Scholarship co chairs traveled to San Diego in early January to meet with the hotel event planner and GF National Vice president. This visit also provided an opportunity for us to attend the induction of new members to the California Chapter This was the first time all Girl Friends received an invitation to the Eunice Shreeves Scholarship Fundraiser Luncheon via mail chimp and chapter presidents. The luncheon was a a great success with 250 tickets sold. The best Silent auction ever, San Diego charm and other jewelry were sold out. We had the pleasure of live entertainment provided by Johnny Britt. The Chapter Presidents and Liaison parade was lively and fun with an increase in presidents participation.

The class of 2023 scholars were introduced for the first time. Fifteen scholars received \$1,500 per year scholarships for four years and the San Diego Chapter awardee was present and introduced to the public. Testimonials from scholarship recipients validated the purpose of Girl Friends Fund in "Bringing Dreams to Life". GFF is so thankful to GF Joyce Moorehead for establishing The Joyce A. Moorehead Endowment Scholarship with her \$50,000 donation.

The Annual Board of Directors Dinner was held in San Diego. Present directors and committee chairmen attended as well as three former GFF presidents, GF Cecelia Henderson, GF LaVerne Boyd, and GF Ann Pope.

The Board of Directors is constantly reviewing and updating our documents to ensure we are following them and updating them to meet the goals and mission of our organization. Officers descriptions and courtesies policies were updated. The Policy and Procedure Manual was reviewed and updated for our investment fund to meet the changing needs of investing.

At our Annual Membership Meeting five directors were recognized for completing their term on the Girl Friends Fund Board of Directors. New Officers of the Board of Directors were elected in April by the Directors.

I am so thankful that I had the opportunity serve as the 15th President of the Girl Friends Fund Incorporated. As the "Girl Friends Fueling the Future administration ends, I want to say thank you for your trust, encouragement, friendship and support.

## "Bringing Dreams to Life One Scholarship at a Time"

The Girl Friends Fund, Inc (GFF, Inc.) was incorporated in Texas on February 22, 1988 and was recognized as a non-profit charitable organization by a five-year advance ruling from the Internal Revenue Service (IRS) on June 30, 1989. The Final Ruling of the IRS that the GFF, Inc. continue operation as a non-profit charitable organization was received from the IRS on December 1, 2008.

The GFF, Inc. was the brainchild of Girl Friends Ersa Posten and Helen Wright, past national presidents of the Girl Friends, Inc. (GF, Inc.). Prior to the 1987 Girl Friends Conclave, GF, Inc. then national president GF Carolyn Wells appointed a three-member committee to explore the feasibility of securing a 501C-3 public charity tax exemption from the IRS for the GF, Inc. Members of the committee were GFs Joan Sessoms Ford (Chairperson), Helen Wright (GF Advisory Board Chairperson) and Yvonne Gandy. The committee's recommendation to the delegates to the 1987 Girl Friends Conclave approved the establishment of a separate charitable corporation. Tax-deductible contributions could be made to this fund. The mission of this corporation was to provide financial assistance for college bound students who demonstrated financial need and distribution of proceeds from fundraising for other charitable purposes. This separate fund was named "The Girl Friends Fund" (GFF) by vote of the Conclave delegates.

As required for incorporation in Texas, initial Board members elected were Girl Friends Rebecca Kingslow as Chairperson, Lucille Blondin and Joan Sessoms Ford as Directors. They in turn elected interim officers GFs Konnetta P. Sparks, President; and Yvonne Gandy, Secretary-Treasurer to serve until the first GFF, Inc. Board of Directors meeting. As Legal Counsel, Joan Sessoms Ford was charged with preparation of all documents necessary for incorporation and filing with the IRS for tax exempt charitable status. Five members of the Dallas Chapter served as incorporators and signed the document for filing for incorporation on December 22, 1989.

The first meeting of the Girl Friends Fund, Inc. Board of Directors was held at the Peabody Hotel in Memphis, Texas on May 27, 1989, and was convened by Interim President, Konnetta Sparks. Upon her election as the first president of the GFF, Inc., Chrystine Shack assumed the presidential role and proceeded with the meeting. Other initial officers were GFs Margaret Bush Wilson (Vice President), Cecile Springer (Secretary) and Lucille Blondin (Treasurer.) The first Directors were GFs Paquita Attaway, Lucille Blondin, Joan Sessoms Ford, Mae Johnson, Rebecca Kingslow, Irma Roy, Margaret Rucker, Chrystine Shack, Cecile Springer, Margaret Bush Wilson, and Konnetta P. Sparks (ex-officio). A projected three-year budget needed for filing with the IRS was developed by Yvonne Gandy, Konnetta Sparks, Cecile Springer and Helen Wright, dated May 27, 1989. Revised by-laws developed by Joan Sessoms Ford were reviewed and commented upon by the GFF, Inc. Board and the GF, Inc. membership and were approved on May 24, 1990 at the GFF, Inc. first annual meeting in Orlando, Florida and signed by Chrystine Shack (President), Joan Sessoms Ford (Legal Counsel), Cecile Springer (Secretary) and Margaret Bush Wilson (Vice President).

The first fundraiser of the GFF, Inc. was a Girl Friends Fund Wheel. This was a raffle spearheaded by GF Paquita Attaway on May 27, 1992 at the GFF, Inc. Annual Meeting in Pittsburgh, PA. GFs Rebecca Kingslow and Lucille Blondin presented the framework of the GFF, Inc. scholarship program to the Board, and the first scholarship was awarded in 1995 under the guidance of GF Florence Sharpless as Scholarship Chairperson.

The Girl Friends Fund, Incorporated Endowment Fund was established in 2002 during the administration of GF Esther C. Marioneaux for whom the Endowment Fund was later named during the presidency of GF Lynda Carroll. GF Lynda awarded the first Esther C. Marioneaux Endowment Fund medallions to each Girl Friend who made a one-time \$250 donation to the Endowment Fund. This practice has been continued by each subsequent president. In addition to the General Scholarship Fund, through the beneficence of Girl Friends and/or their families, the GFF, Inc. has created five additional "named scholarships," called "Scholarships of Distinction": the GF Carolyn M. Carter Memorial Scholarship, the Anita Peek Gilger, MD Trust; the GF Juanita P. Humphrey Scholarship; the GF Gwendolyn G. Johnson Scholarship; and the GF Carole Temple Phillips Scholarship.

The presidents of the GFF, Inc. have all spearheaded outstanding activities.

GF Konnetta P. Sparks (1989), Girl Friends, Inc. President in 1989, and interim GFF, Inc. President in 1989, led the establishment of the GFF, Inc. through every stage of its creation. She is considered the "Mother of the Girl Friends Fund, Inc.", and evidences the close bond between the GF, Inc. and the GFF, Inc.

GF Chrystine Shack (1989 – 1992) oversaw the approval of the Revised Bylaws, the approval of the first GFF, Inc. fundraiser and development and advancing of the framework for the Scholarship Program during her tenure.

GF Helen K.Wright (1992 – 1995) initiated a significant fundraiser of printing the GFF, Inc. bylaws in booklet form and sold to Girl Friends for \$10 each booklet and assured the purchase of the first Certificates of Deposit by the GFF, Inc.

GF Miriam Shropshire (1995 – 2000) worked tirelessly to raise money for GFF, Inc. scholarships.

GF Esther C. Marioneaux (2000 – 2002), in addition to starting the GFF, Inc. Endowment Fund, changed the composition of the Board to create transition terms to ensure that experienced Directors always remained a part of the Board.

GF Lynda P. Carroll (2002 – 2005) initiated the giving of medallions for contributions of \$250 to the Endowment Fund. She oversaw the renaming of the Endowment Fund in honor of GF Esther C. Marioneaux, and initiated perpetual plaques inscribed with the names of Girl Friends giving \$250 or more. GF Linda also prepared the first Annual Report.

GF Phoebe A. Haddon (2005 – 2007) consulted with a Certified Public Accountant (CPA) to identify GFF, Inc. financial data inadequacies and proposed a contract with that same CPA to correct those inadequacies and preserve the GFF, Inc.'s tax exempt status.

GF Carole T. Phillips (2007 – 2010) worked with the GFF, Inc.'s CPA in retrieving needed financial data for filing with the IRS. She secured the IRS Final Determination letter of tax exemption as a public charity for the GFF, Inc. required after the five-year advance ruling period. She created the Endowment Fund Certificates to honor donations beyond the initial \$250 donation. The Carole Temple Phillips named scholarship was created in 2010 by the then Board of Directors and made a recurring scholarship by GF Carole in 2014.

GF Elaine Effort (2010 – 2012) launched the Girl Friends Fund, Inc. website, with a generous donation from the family of Cleveland GF Lillian H. Gregory, with legacy Girl Friends in the Cleveland, Potomac and California chapters. The GF Fund's interactive website allows scholars to apply online, encourages chapters to share special events and updates, and makes it easy and safe for GF members, family members, friends and other community and business resources to support the Fund through online donations.

GF Andrea L. Johnson (2012 – 2013) completed a comprehensive revision of the GFF, Inc. bylaws. She contracted for, and finalized, a complete GFF audit by a CPA established a Conflict-of-Interest Policy for the Board and established the GF Gwendolyn G. Johnson Scholarship in honor of her mother.

GF Cynthia Carter Cole (2013 – 2015) oversaw the GFF, Inc.'s most successful Silent Auction, partnering with St. Johns Knits to develop "GFF Shopping Days" that provided members a discount and allowed GFF, Inc. profit sharing. She also secured underwriting of a portion of the GFF, Inc. Luncheon by St. Johns Knits. GF Cindy partnered with the David Yurman Outlet in Las Vegas, which provided members discount shopping. She established the GF Carolyn M. Carter Scholarship in her mother's honor. GF Cecelia B. Henderson (2015 – 2017) commissioned a limited-edition bracelet engraved with the GFF, Inc. logo on one side and 'Bringing Dreams to Life'' on the other side. Bracelets were marketed to Girl Friends as a fundraiser. She also started the GFF, Inc. Book Fair in 2017 through partnership with Barnes and Noble. She initiated personalizing the Esther Marioneaux Endowment Fund Medallions with the name and Conclave date of the donors.

GF LaVerne N. Boyd (2017 – 2019) successfully secured the trademarking of the GFF logo and the motto "Bringing Dreams to life" and initiated the implementation of a QuickBooks Financial Program for the membership of the GF, Inc. GF LaVerne commissioned a commemorative sterling silver bracelet, to memorialize the 2019 New York and future Conclaves. A Pioneer Campaign was also originated under her administration which, concurrently with the 30<sup>th</sup> Anniversary of the Fund, celebrated 48 Pioneer Girl Friends who initiated and formed the foundation for the Fund in a historically successful campaign at the 2019 Eunice Shreeves Luncheon.

GF Ann E. Walters-Pope (2019 - 2021) advanced technical tools to facilitate communication with members and launched an individual member email communication system to reach the Fund's over 1700+ members.

The amendment to the Bylaws of The Girl Friends<sup>®</sup>, Inc., including the provision that the funding from the National Project will now be awarded to The Fund on even years passed successfully. GF Ann implemented an online donation platform, Give Lively, that tracks donations and immediately sends Thank You responses. During this unprecedented pandemic, GF Ann designed and implemented the first ever Giving Tuesday Campaign that raised over \$16,000. Additionally, under her administration a first-time partnership with the Alzheimer's Association was established resulting in the funding of a named scholarship and the Fund's participation in their R25 grant that ensures a recipient will be a GFF Scholar. She designed the artwork for the ScholarSip campaign mug which collaboratively realized revenues of more than \$10,000, selling nearly 550 mugs. The GFF Bylaws were reviewed thoroughly, and proposed amendments sent to the members for review and approval. GF Ann created the 2021 Eunice Shreeves Scholarship luncheon format and theme, Pairings with a Purpose, which for the first time sold an unprecedented 280 tickets with income in excess of \$40,000.

All members of The Girl Friends, Inc. are members of The Girl Friends Fund, Inc. We are one team with one mission. In recognition of the special importance of access to higher education for all and despite widespread economic instability and rising tuition costs we remain committed to eradicating the inequalities in educational opportunities in particular for African American young women and men that are low income and under-represented in universities

and colleges across America. We have strength in numbers! We are a lifeline to our aspiring scholars and will remain so!

We gratefully acknowledge the historical work of the 2015 – 2017 History Committee: Co-Chairs GF Nina Jennings and GF Sheila J. Williams, the 2001 History of GF Cecile Springer, and the efforts of G.F. Lynne Bannister.

We also acknowledge GF Joan Sessoms Ford, Esq. for providing this history write-up and also note that additional updates were added in May 2021.



## INVESTMENT REPORT



During the past year, The Girl Friends Fund Investment Committee has continued to monitor and review the two endowment accounts held at Ameriprise Financial Services Incorporated (AFSI) under the direction of William Babgy, the account manager.

The Esther Marioneaux Endowment Fund, established in 2014, is comprised of all scholarship funds invested to preserve long-term capital to fulfill our primary mission of providing college scholarships to deserving youth. The investment objective of this account is to deliver

risk-adjusted growth of capital in a moderately aggressive portfolio. The current balance in this account as of June 30, 2023, is \$424,165.15 and fees assess during the past year were \$4,103.

Each year since 2021, the Investment Committee has recommended and the GFF Board has approved two full scholarships of \$6,000 each to be awarded from this Ameriprise account. The Investment Committee continues to monitor the performance of this account and determines annually the amounts that can be awarded for new scholarships while preserving the principle.

The second account at Ameriprise was established in 2021, the GFF Restricted Scholarship Fund. It includes scholarship funds that have already been designated and awarded to previously named scholarship recipients. The current balance in this account as of June 30, 2023, is \$140,090.51 and fees assessed were \$1,121. Based upon our goal of preserving capital to be awarded as needed during a four-year period, the investment allocations for this account are in a moderately conservative portfolio. The Investment Committee recently met Mr. Babgy, our Ameriprise account representative, to consider investment options and changes given market volatility during the past year. The Committee is currently reviewing even more conservative options, such as money market and investments in cash options to preserve capital. Each year, in September, the Scholarship Committee reports the number and amounts required for outstanding scholarships and the funds are withdrawn from this account and deposited to the GFF's operational account so that checks can be prepared for continuing scholarship recipients.

This year, we are very pleased to announce that GF Joyce Morehead and her husband, BF Thomas, Morehead have established a GFF Scholarship Endowment of \$50,000.00 in their names at Ameriprise to be awarded annually. We are deeply appreciative for their generosity and for their support of the GFF and our future scholars.



I am pleased to provide a summary of your investments held at Ameriprise Financial. The Girl Friends Fund Inc. (GFF) Investments are professionally managed by Ameriprise Financial Services, Incorporated (AFSI) .The GFF general account is invested in an Actively Diversified Fund with a Moderately Aggressive asset allocation.The GFF Restricted Scholarship Fund is invested in a Conservative asset allocation.

All GFF Fund accounts are invested in a fund of funds. The portfolios are actively advised by an unaffiliated portfolio consulting firm, Wilshire Associates, Incorporated (WAI). WAI advises AFSI on asset allocation and selects the fund managers. WAI is consultant to a number of large endowments, foundations, pension plans, and for and not for profit institutional investors. Despite the financial volatility associated with the challenges faced during the past fiscal year, the investment returns were positive as of June 30,2023 for both the general Esther Marioneaux Endowment account (10.6%) and the Restricted Scholarship account (3.0%). The combined total return for these two accounts is 10.4%. Note that the total balance for June 2023 includes the recently added endowment account established by GF Joyce Morehead and husband, BF Thomas. Please see below the attached performance reports for June 2022 compared to June 2023.

It has been a pleasure to work with the Girl Friends Fund financial leadership team and I appreciate your trust in allowing us to help you achieve your mission.


Girl Friends Fund Scholarship Committee was pleased to provide opportunities for Girlfriends across the country to support student success through the Girl Friend Fund, Inc. The Scholarship Committee was tasked to organize and execute the 2022 - 2023 Scholarship Cycle and Scholars Renewal Process. The Scholarship Committee Members are: GF Sonya Goldsboro (Las Vegas), GF Faith Hairston (Toledo), GF Annette Johnson (Albany), GF Jacqueline Randolph (New Haven), GF Cheryl Smith (Orlando), GF Nedra Starling (Cleveland), and GF Tamara Turnley-Robinson (Atlanta).

#### 2022 Scholars Renewal Process

Each year, the Scholarship Committee reaches out to our scholars during the months of May - August 2022 to encourage the scholars to renew their scholarships. The scholars are eligible to renew the scholarship annually (up to four (4) years consecutively). The scholars must meet the renewal process criteria: (a) a minimum cumulative 3.0 GPA at the end of each academic year; (b) enrolled full-time in an accredited four-year undergraduate institution; (c) completion the Returning Scholars Renewal Form; (d) official transcript; and (e) enrollment verification.

- 51 Past scholars were eligible to reapply for the scholarship with 44 scholars reapplied for the scholarship.
- 41 scholars met the renewal requirements and received the annual scholarship which included six (6) \$1,000 scholarships.
- The scholarship checks were distributed in September 2022 along with the 15 new 2022 Scholarships.

For the 2023 renewal scholarship cycle, the Scholars will be emailed in May 2023 with instructions regarding the online renewal form and submission of an official transcript and enrollment verification by July 31st. The online renewal form will be available on the Girl Friends Fund website between June 1st – July 31st. Scholarship checks will be distributed in September 2023.



#### 2023 New Scholars Cycle





Hello GFs,

The Fund had been asked on several occasions by different chapters and Girl Friends if it could be used as a "Pass thru" for funds for conclaves since GFF has non profit IRS designation. We researched and investigated and the GFF cannot be a pass thru for the GF Inc.

Giving Tuesday was a success, we updated our website and continue to sell GFF jewelry.

GFF has Consolidated our bank accounts to make them more effective and efficient. We made sure we received the best interest rates possible on our accounts. Consolidating accounts was made to simplify our finances.

Investment Committee has been monitoring our assets with Ameriprise Financial and working closely with our financial advisor to generate the best outcome. Regular meeting to review accounts are held.

Silent Auction was a huge success. Auction items provided by chapters and individuals were top quality.

Scholarships were awarded to 15 students for \$1500 per year for four consecutive years. 21 Applications from chapters were submitted. Readers of applications cannot belong to a chapter that submits an application. The first introduction of scholarship winners was the the luncheon.

Various ways to give to the GFF include the Chapter and Member challenge. First time givers (\$300) receive the Esther Marioneaux medallion. Matching funds with your corporation is another way of giving as well as corporate and individual donations. Anyone may contribute to GFF. Donations are tax deductible.

\$25,000 is the minimum amount to establish an endowed named scholarship. The minimum for a scholarship in honor or in memory of is \$6000 which covers a 4 year scholarship for one student.

IRS form 990 has been filed with the auditors, a correction has been made and will be available on the website for members to view.

Scholarship Report given by GF Fawn Robinson & GF Faith Hairston

We awarded 15 scholarships to the following deserving students:

### 2023 Scholars SLIDE PRESENTATION

2022 Scholars Renewal Process (May 2022- September 2022)

- 51 Past scholars were eligible to reapply for the scholarship with 44 scholars reapplied for the scholarship.
- 41 scholars met the renewal requirements and received the annual scholarship which included six (6) \$1,000 scholarships.
- 3 did not meet the renewal criteria
- 7 no contact/ did not apply
- The scholarship checks were distributed in September 2022 along with the 15 new 2022 Scholarships.

2023 Renewal Process has already begun. Communication has gone out to the current Scholars. July 31st is the deadline for submitting their renewal form, transcripts, and fall schedules. If we are not able to get in contact with the scholar, we will reach out to the chapters.

### 2023 Scholarship Cycle (September 2022-September 2023)

The committee conducted a training session on January 29, 2023 with 10 Girlfriends attending the session. With the March 1st deadline, the Scholarship Committee received 26 applications which was an increase of 5 applications from last year. 26 chapters submitted a scholarship application for the 2023 Scholarship Cycle and there were 17 Scholarship Reviewers from nine Girlfriend chapters. The 2023 GFF Scholars were announced at the GFF Luncheon. Chapters are encouraged to reach out to their scholars as the official notification from the Board will be sent mid-June. The chapter representative will be cc'd on the notification to the scholar.

After eight years, I am stepping down as Scholarship Chair and GF Faith Hairston from Toledo will be the chair starting July 1st. Thank you for the support over the years.

Investment Report read by GF Lori Parker on behalf of GF Jacqueline Hrabowski

During the past year, The Girl Friends Fund Investment Committee has continued to monitor and review the two endowment accounts held at Ameriprise Financial Services Incorporated (AFSI) under the direction of William Babgy, the account manager.

The Esther Marioneaux Endowment Fund, established in 2014, is comprised of all scholarship funds invested to preserve long-term capital to fulfill our primary mission of providing college scholarships to deserving youth. The investment objective of this account is to deliver risk-adjusted growth of capital in a moderately aggressive portfolio. The current balance in this account as of April 30, 2023, is \$410,723.55.

Each year since 2021, the Investment Committee has recommended and the GFF Board has approved two full scholarships of \$6,000 each to be awarded from this Ameriprise account. The Investment Committee continues to monitor the performance of this account and determines annually the amounts that can be awarded for new scholarships while preserving the principle.

The second account at Ameriprise was established in 2021, the GFF Restricted Scholarship Fund. It includes scholarship funds that have already been designated and awarded to previously named scholarship recipients. The current balance in this account as of April 30, 2023, is \$139,852.91. Based upon our goal of preserving capital to be awarded as needed during a four-year period, the investment allocations for this account are in a moderately conservative portfolio. The Investment Committee recently met Mr. Babgy, our Ameriprise account representative, to consider investment options and changes given market volatility during the past year. The Committee is currently reviewing even more conservative options, such as money market and investments in cash options to preserve capital. Each year, in September, the Scholarship Committee reports the number and amounts required for outstanding scholarships and the funds are withdrawn from this account and deposited to the GFF's operational account so that checks can be prepared for continuing scholarship recipients.

This year, we are very pleased to announce that GF Joyce Moorehead and her husband, BF have established an GFF Endowment of \$50,000.00 in their names at Ameriprise to be awarded to two scholars annually. We are deeply appreciative for their generosity and for their support of the GFF and our future scholars.
